5. **Bibliography:** A complete list of sources referenced in your article.
6. **Sources:** Include any primary sources or data used in your analysis.

LANGUAGE REQUIREMENTS

Articles should be written in English or French (or both). However, Arabic submissions are welcomed but must be accompanied by a commitment to respond promptly regarding translations approvals.

VISUAL CONTENT

If your article includes external images, please ensure you provided the source of each image, and confirm that you have the rights or licence to use these images.

ADDITIONAL INFORMATION FOR NEWCOMERS

New authors should submit a professional photograph along with a short biography (100-150 words) detailing their background and expertise.

PAYMENT AND CONTRACT

Upon receipt of your article, we will review it and send you a contract after its publication. Once published, you will receive a payment in the month of the publication of your article (count max 30 days). **Each payment will proceed only if the researcher sends us an invoice with detailed information** (name, price: **150€**, tax number, address, banking information and to whom the invoice should be sent, in this case EISMENA, and at the very end the signature), **and a signed contract**.
